- EXHIBITOR AND OWNER ACKNOWLEDGE ALL HAZARDS PRESENTED BY THE EVENT AND THE EVENT PREMISES, INCLUDING, BUT NOT LIMITED TO, THE CONDITION OF THE FLOORS, STAIRWAYS, HALLS, LIGHTING, SECURITY MEASURES (OR LACK THEREOF), ELECTRICAL APPLIANCES, SHOW RINGS, PARKING AREAS AND THE PRESENCE OF UNFAMILIAR ANIMALS AND PEOPLE. EXHIBITOR AND OWNER ASSUME THE RISK OF ANY HARM ARISING FROM THESE.
- EXHIBITOR AND OWNER RELEASE ASCA AND WILL DEFEND ASCA AND HOLD IT HARMLESS FROM ALL PRESENT AND FUTURE LOSS, INJURY, DAMAGE, CLAIMS, DEMANDS AND LIABILITIES INVOLVING THE ENTERED DOG, THE EVENT, OR THE EVENT PREMISES.
  - FOR EXAMPLE, SHOULD THE ENTERED DOG INJURE STOCK, THE OWNER WILL PAY FOR VETERINARIAN SERVICES. IF THE INJURY IS SEVERE, OWNER WILL PAY THE MARKET VALUE OF THE STOCK.
