## **AGREEMENT**

- 2. EXHIBITOR AND OWNER CERTIFY THAT THE ENTERED DOG IS NOT A HAZARD TO PERSONS, DOGS OR PROPERTY.
- 3. EXHIBITOR AND OWNER ACKNOWLEDGE ALL HAZARDS PRESENTED BY THE EVENT AND THE EVENT PREMISES, INCLUDING, BUT NOT LIMITED TO, THE CONDITION OF THE FLOORS, STAIRWAYS, HALLS, LIGHTING, SECRUITY MEASURES OR LACK THEREOF, ELECTRICAL APPLIEANCES, SHOW RINGS. PARKING AREASA AND THE PRESENCE OF UNFAMILIAR ANIMALS AND PEOPLE: EXHIBITOR AND OWNER ASSUME THE RISK OF ANY HARM ARISING FROM THESE.
- 4. EXHIBITOR AND OWNER RELEASE ASCA® AND WILL DEFEND ASCA® AND HOLD IT HARMLESS FROM ALL PRESENT AND FUTURE LOSS. INJURY. DAMAGE, CLAIMS, DEMANDS AND LIABILITIES INVOLVING THE ENTERED DOG, THE EVENT OR EVENT PREMISES.
