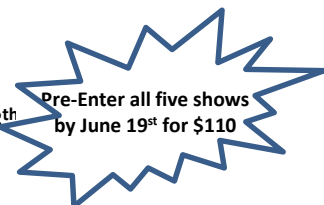

**From the South:** Take I-75 to I-275 north, take exit 25. Turn left onto 38<sup>th</sup> Avenue N. Turn right at 2<sup>nd</sup> traffic light, 34<sup>th</sup> Street, N. Turn left into lot just after overpass (tile store in front).

**From the East:** I-4 east to I-275 south. Follow directions for traveling from the north.

## ~ Attention Exhibitors ~

- No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA
- The show will be judged and run under the show rules for the Australian Shepherd Club of America
- Exhibitors can access the building Friday June 26<sup>th</sup> from 6pm to 8pm and then 7:00 am Saturday June 27<sup>th</sup> and 7:30 am June 28<sup>th</sup>
- The show site will close 30 minutes after all judging is completed June 27<sup>th</sup> and 60 minutes after judging completed June 30<sup>th</sup> unless changed by Show Secretary
- Grooming space is limited please be respectful of all exhibitors
- Due to padded mat flooring, all wire crates must have mats underneath them, if you will be grooming inside the building place a 8'x10' tarp down on the ground to cover your grooming and crating area all tables must have rubber or plastic feet. There will be NO ex-pens in the building
- Availability of electricity is very limited. Use of electricity maybe restricted as needed by the Show Secretary
- Show Secretary has the authority to change rules for the safety & control of dogs & exhibitors. We reserve the right to require the stacking of crates and any other remedies necessary for consolidating space on a case-by-case basis at their discretion
- No refunds will be given for dogs absent, disqualified, excused, or barred from exhibiting by the show committee
- FASA reserves the right to make refunds up to the close of the pre-entry deadline
- No entry which specifies any conditions as to its acceptance will be accepted
- No electrical or mechanical training devices are allowed on the show grounds
- Entries must be made on official ASCA entry forms
- Copies of entry forms will be accepted only if they are completed with the agreement on the reverse side
- We expect all exhibitors to display good sportsmanship
